#### <u>17/589P</u> <u>DA/2017/1002</u> <u>Siting of storage container</u> <u>St David's Recreation Ground, Brixworth, Northamptonshire</u>

<u>17/5908P</u> <u>DA/2017/0999</u> <u>Work to trees within the Conservation Area</u> <u>25 Church Street, Brixworth, Northamptonshire</u> The Parish Council objected to this proposal as the information provided was insufficient and it was not possible to make an informed comment. This was proposed by Councillor Coles and seconded by Councillor James. Unanimous.

#### 17/592P Any Other Urgent Business

#### DA/2017/01422 (Notice of Appeal) Construction of vehicular crossover and hardstanding 73 Spratton Road, Brixworth, Northamptonshire

An appeal had been lodged against the District Council's decision to refuse this application.

#### Settlements and Countryside Local Plan Part 2 – Emerging Draft Consultation

Daventry District Council is consulting on the Emerging Draft Settlements and Countryside Local Plan (Part 2)

A public exhibition will take place at Brixworth Library on Thursday 7th December 2017. (2pm until 6pm)

Mr Parsons (Neighbourhood Planning Group) was in attendance and commented that the Brixworth Special Landscape Area did not feature on any of the revised plans and this matter had been raised with the Planning Authority. A reply was awaited. Concerns were also expressed regarding Planning Policy R1 – which limits the numbers of rural houses. There was also a possible re-designation of Brixworth to a 'primary service village' status. This potential re-designation would identify Brixworth as a larger community where further housing growth would be considered. The Steering Group would be making a series of observations on these proposals.

The public consultation exercise would run from 27th November 2017 until 26th January 2018.
