<u>Building To Rear Of 105A, Northampton Road, Brixworth, Northamptonshire</u>

A planning consultant together with the applicant addressed the meeting. The proposal for a Podiatry Clinic was outlined to the Planning Committee. The Parish Council had no objections to the proposal. This was proposed by Councillor Peacock and seconded by Councillor James. Unanimous.

Change of use of land to residential garden with two outbuildings (Retrospective).

Land Adj 36, Knightons Way, Brixworth, Northamptonshire, NN6 9UE

The Parish Council objected to this proposal on planning grounds as contained in the West Northants Joint Core Strategy, Daventry District Council saved policies, Brixworth Neighbourhood Plan and the Brixworth Village Design Statement. This was proposed by Councillor Barratt and seconded by Councillor Mitchell. Unanimous.

General - Contrary to application DA/1993/0046 which had been approved by DDC. The description of the land in the application was disputed. The land should not be classified as wasteland.

Neighbourhood Plan – This is confirmed woodland, shown as a green strip, which should be protected under policy 4(1)

It does not meet the criteria allowing development outside the village in Brixworth Neighbourhood Plan policy 2 (1 to 4) which does not offer an exception for this development to take place.

An impact assessment had not been provided, nor mitigation measures contravening Neighbourhood Plan policy 2 (7)

Contrary to Brixworth Neighbourhood Plan Policy 4. "Mature trees and woodlands and important hedgerows should be protected where possible". And development "will not be permitted unless replacement or mitigation is agreed"

Contrary to Brixworth NP Objectives in 5.7 "protection of environment......valued landscape and valued amenity and green spaces within the Parish"

Contradicts Brixworth NP Vision 5.6 "thriving natural environment with sustainable wildlife"

It is not in accordance with Brixworth Neighbourhood Plan 5.3 "the sensitivity of the landscape in the periphery of the village" as fully explained in the independent Northamptonshire Landscape Character Assessment, Lockhart and Garratt, August 2014)

Village Design Statement. Village Design Statement 3.2 has concern re "threat of urbanisation along the

A508" Removal of a section of the natural sound barrier protection strip is clearly the beginnings of urbanisation. The A508 is the road adjoining the east side of the barrier strip.

Contrary to VDS policy LG5 "residents should be encouraged to maintain and manage existing trees and hedges adjoining them"

Contrary to VDS policy LG7 "established green boundaries should be preserved and enhanced"4

VDS map 2. The area is classified as "hedgerows and screens worth preserving"

Local Plan. Outside the village boundary contrary to DDC saved policy HS14

Contrary to DDC saved policy GN1a - protect natural resources"

Contrary to DDC saved policy GN1B - protecting and enhancing the environment

Contrary to policy GN2(f) – should be protected as a natural site

Contravenes DDC saved policy E25(E) "existing trees, hedgerows and woodlands should be retained where possible"

Contrary to E42(E) "existing landscape attributes to the site are incorporatedto ensure the developments environmental effect is minimalised.

Joint Core Strategy. The reduction of this open land is contrary to policy RC2 of West Northants Joint Core Strategy Local Plan "loss of community facilities including areas of open space will be resisted unless replacement facilities of equal or better quality are provided."
